












Special Focus on the Plastics Sector & Product trade


This section consists of an abbreviated summary of salient trends, relationships and ratios for the Plastics Sub-sector.


A further objective is to show some of the detail data availabile and potential for more disaggregated analysis. International trade data is classified according to the harmonised system (HS) of tariffs. To enabling linkages to domestic industrial data, the former/trade data is reclassified according to the standard industrial classification (SIC) for SA.)



The schematic above shows the 2023 input, value added (sub sector GDP) and output as well as international trade in intermediary and final products, for plastics, according to the SIC classification.


The **Plastics production** trendline shows continues improvement since the middle of 2021, after the Covid restrictions and a second shock mid 2021.







Plastics Sales showed a near 6% increase in actual numbers, but the average inflation was just over 6% resulting in inflation adjusted sales being fairly 'flat' for the year up to August.
