
#### LEGISLATIVE MANDATE OF THE SABS

- > Render conformity assessment services and matters connected therewith

- Section 24 Issuing of South African National Standards notice in the Government Gazette
- Section 25 Recognizing Standards Development organisations
- Section 26 Copyrights in South African National Standards and publications of SABS
- Section 28 Incorporation of South African National Standards in Law







	Objectives
1.	Develop and maintain <b>relevant</b> national standards that address <b>market needs</b> , support and enable socio-economic and environmental objectives, industrial policy, innovative and competitive industries
2.	Maintain a <b>credible, inclusive,</b> and <b>efficient</b> national standards development system and processes underpinned by international standardization principles and digital enablement
3.	Acquire, develop and retain skills to drive strategic and thought leadership, achieve stakeholder diversity amongst the pool of professional standardizers and meet the changing needs of society
4.	<b>Promote</b> the widespread use of SANS through enhancing the public understanding of the value of SANS and related conformity assessments and demonstrate the benefits and positive <b>impacts</b> to the public and private sector
5.	Strategic collaboration and leadership in regional and international standardization forums; active participation in the harmonization of standards and conformity assessment tools to support the implementation of the AfCFTA
6.	Enhance the <b>access</b> , distribution, and <b>uptake</b> of national standards by all stakeholders


